There was discussion on spending money on equipment, improving AEC, and/or increasing donations to scholarships or International Health. There have been requests for the presentations to be video recorded; there are often two or more good sessions at the same time and it would be nice to be able to view them. Perhaps a conference login to access the presentations. WSEHA could invest in some projectors for AECs since many that are used are borrowed.

Mike will look at the cost of purchasing video equipment versus video service.

Joe brought up using a conference app for attendees. The cost to print programs this year was \$1,185.

There was discussion on what a reasonable reserve should be for the organization.

- 2020 AEC
