Scholarship Opportunity

The Washington State Environmental Health Association's Board of Directors has authorized up to **\$2,000** for undergraduate scholarships this year through its **Cind M. Treser Memorial Student Scholarship Fund**. The Scholarship program was instituted to provide recognition and a financial incentive for <u>undergraduate</u> students majoring in environmental health (or in other life sciences), who have an interest in pursuing a career in environmental health in the state of Washington. The program was named for Cind M. Treser, who served as the Association's Executive Secretary for many years following her untimely death in 2000 at the age of 53, to commemorate her many contributions to the Association.

The scholarship competition is open to all undergraduate students attending one of Washington State's four year academic institutions, who have an interest in employment as an Environmental Health Specialist in Washington. The award(s) will be presented at the WSEHA 63rd Annual Educational Conference May 12 & 13, 2014 at the Great Wolf Lodge in Grand Mound, Washington.

General Criteria: In order to be eligible for the scholarship, the student must:

- 1. Be enrolled in a program either accredited by the National Accreditation Council for Environmental Health Curricula, <u>or</u> have a curriculum comparable to the model curriculum recommended by the National Accreditation Council, i.e., the program should include substantial coursework in the following areas;
 - a. Biology and Microbiology,
 - b. General and Organic Chemistry,
 - c. Epidemiology,
 - d. Biostatistics, and,
 - e. Environmental Health Sciences (i.e., food protection, air pollution, water and wastewater, solid waste, vector control & housing, toxics & hazardous substances, hazardous waste, etc.);
- 2. Be a student member of WSEHA, or become a member upon receipt of the scholarship;
- 3. Demonstrate his/her intent to become employed in the field of environmental health in Washington fol-lowing graduation;
- 4. Have submitted a completed Scholarship Application form, and be willing to submit a photograph if awarded the scholarship:
- 5. Be able to attend the WSEHA Annual Education Conference to receive the scholarship award; and,
- 6. Not be a previous winner of the award.

Special Criteria: Students of color and specially challenged students are encouraged to apply.



International Health Committee

For the 2014 Silent Auction at the Annual Education Conference, the WSEHA International Health Committee (IHC) has decided to re-visit one of its old friends. Water 1st International has been chosen as our featured project for the Silent Auction, to be held at the 2014 AEC at the Great Wolf Lodge.



This year's project will feature the IHC's second collaboration with Water First International. Water 1^{st} was our featured project at the 2007 AEC in Yakima. Their fo-

cus project back then was providing water supplies for people in the Sunderban region of eastern India.

Water 1st International's current focus involves their ongoing efforts to establish community water points that connect to public water supply pipelines in urban slum environments in Dhaka and Chittagong, Bangladesh, as well as providing options for community toilets. Community-mapping exercises identify sites for new water points and toilets, with



the goal of providing full water supply and toilet coverage in a defined area of the slum.

WAC 246-272A & RS&G's Review for Regulators

There will be a Special Onsite Sewage Course at WSEHA's Annual Educational Conference on May 12-13, 2014 at the Great Wolf Lodge in Grand Mound, Washington.

The "WAC 246-272A & RS&G's Review for Regulators" course is instructed by Leigh McIntire from WOSSA (Washington Onsite Sewage Association). This 1 ¹/₂ day program will be a review of the WAC 246-272A and



RS&G's for local health jurisdiction (LHJ) staff responsible for reviewing OSS design applications. It will be suitable for LHJ staff who are looking for a more in-depth understanding of design application and for those that are preparing to sit for the Department of Licensing exam for certification. This class is appropriate for new regulators in the on-site discipline; however, participants should have a working knowledge of the code or appropriate experience to contribute to the discussion.



Because of extra costs associated with course materials, an additional fee of **\$75.00** is required for those registering for this course. This fee is in addition to the appropriate registration fee for the WSEHA 2014 Annual Educational Conference outlined on the registration form. (This course in WOSSA's regular schedule would be a \$350.00 program, so this is a real value.)
